## 1. Registration Guidelines

- 1.1 You can register as an Institutional team.
- 1.2 The deadline of the registration for the 1<sup>st</sup> NUSRL legal Aid Fest, 2015 is 21<sup>st</sup> April.
- 1.3 The deadline for depositing registration amount is 25<sup>th</sup> of April, 2015.
- 1.4 Once the participants have deposited the registration amount, they will not be allowed to withdraw from the respected events or back out from the competition.

## 2. Payment Details:

- 2.1 For the events, we are accepting payment only via Demand Draft. Please note that no part payment will be accepted.
- 2.2 Registration Fees for Teams (Including Accommodation & Fooding for the entire Event): INR 1000 per participant.
- 2.3 For teams who do not require accommodation, team registration fee for the events will be:-
  - Symposium: INR 500 (per team)
  - Client counselling: INR 500(per team)
  - PIL Drafting competition: INR 500 (only for oral rounds)
  - Street play competition: INR 1500 (per team)
  - Socio-prenuer: INR 500 (per team)

## 2.4 Follow the steps mentioned herein to complete your payment process:

**Step 01:** Upon completion of filling up of the Registration form, for payment of registration fees a Demand Draft (D.D.) in favour of REGISTRAR NUSRL, RANCHI payable at Ranchi as per the details mentioned hereunder is to be prepared.

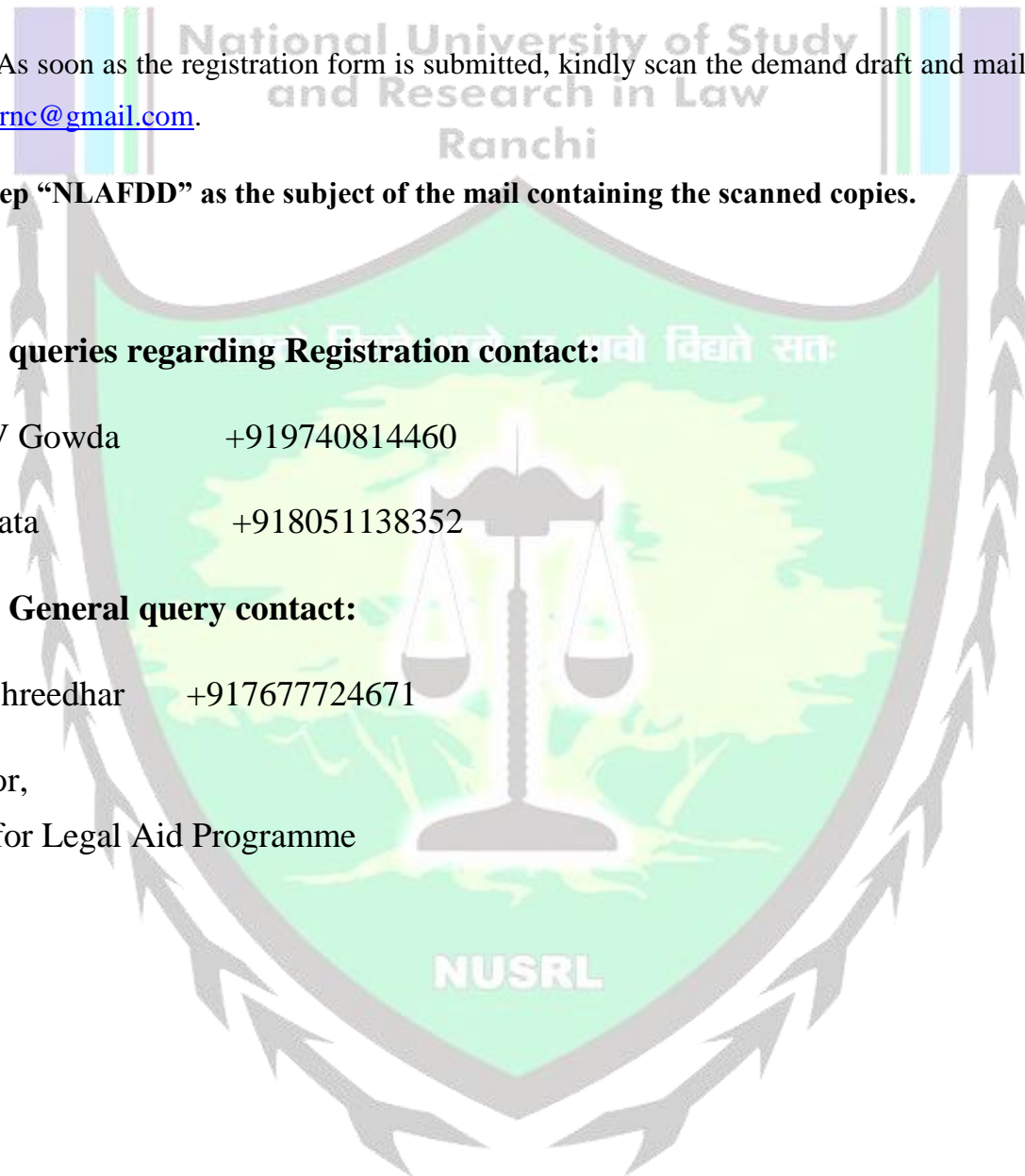

## GENERAL RULES

1. Damages to the property of site of accommodation or any damage to the NUSRL campus will not be condemned.
2. Participants are solely responsible for their belongings. Organising team does not bear any responsibility for the same
3. Any person found in possession of, or under the influence of alcohol or narcotic substances will be expelled from the premises. They will further be reported to their concerned college authorities.
4. Any person in indecent clothing or involved in obscene behaviour will result in cancellation of his/her registration and disqualification from the fest. The decision of the authorities will be final in this regard.
5. The participants are supposed to conduct themselves with dignity, modesty and simplicity.
6. The Rules governing the conduct of the Competition should be strictly adhered to. Any deviation thereof can attract penalties or disqualification at the sole discretion of the Competition Administrator.
7. All the participants should carry their college / University I-cards and a team bonafide certificate/Registration form attested by the head of the institution.
8. The decision taken by the judges in all the events will be final.
9. In case of any issue, the decision taken by the Organisers will stand final.
10. These rules stated above are subject to change on the discretion of the organisers.
